## 1 Introduction

## 1.1 Background and purpose

ICA Gruppen believe that sustainability work and strong community engagement goes hand in hand with long-term profitability. Sustainability is a strategic priority and is integrated into all of ICA Gruppen's operations. ICA Gruppen's operations extend across many areas: Grocery retail, Pharmacy business, Construction and Real Estate operations, as well as Banking and Insurance services. The breadth of the business means the Group has an impact in a great many areas. ICA Gruppen aim to develop our business with the customers and long-term sustainability in focus. Customers and other stakeholders must feel secure and have confidence in ICA Gruppen and its business.

ICA Gruppen has signed the UN Global Compact and has committed to its Ten Principles covering human rights, labour conditions, the environment and anti-corruption. Together with the UN's Sustainable Development Goals and ICA Gruppen's policies and general guidelines, they form the framework for ICA Gruppen's sustainability work. ICA Gruppen's sustainability work must be credible and transparent, and based on the company's actual and potential impacts on people, the environment, and communities. ICA Gruppen's suppliers and other business partners must comply with the legislation in force throughout their operations in the countries where they operate.

The Sustainability Policy and the general guidelines describe ICA Gruppen's overarching position on sustainability matters beyond the requirements set out in the legislations. All of ICA Gruppen's employees, suppliers and business partners are expected to follow these.

The areas of tax, business ethics, the work environment, and diversity & inclusion are areas linked to sustainability and are subject to separate policies and guidelines.

#### 1.2 Scope

The general sustainability guidelines apply to all operating companies (OpCos) within ICA Gruppen. Guidelines for Banking and Insurance, Construction and Real Estate operations, Retail & Pharmacy can be found in ICA Gruppen's sector-specific guidelines.

#### 1.3 Communication and implementation

Chief Corporate Responsibility Officer ensures that the latest version of the general sustainability guidelines is published on ICA Gruppen's intranet.

The CEOs of the respective OpCos are responsible for implementation of and compliance with the sector-specific sustainability guidelines as well as the general sustainability guidelines that apply throughout ICA Gruppen.

ICA Gruppen's working practices for sustainability will be regularly reviewed and evaluated to ensure continual improvement.

# 2 Sustainability Guidelines

## 2.1 Information about ICA Gruppen's sustainability work

Through clear communication ICA Gruppen provides a transparent account of the sustainability work to both internal and external stakeholders. Companies within ICA Gruppen will actively provide information about the sustainable value added to our products and services, and market them accordingly. ICA Gruppen reports annually on the progress made around corporate responsibility and sustainability, both in annual reports and on ICA Gruppen's website.

Regardless the subject ICA Gruppen's customers, employees, suppliers and business partners shall have clear channels to contact us.

## 2.2 Quality assurance of product, services, and suppliers

All products and services provided by OpCos within ICA Gruppen shall be safe and functional as well as being environmentally and ethically acceptable.

ICA Gruppen encourage customers to adopt a healthy and sustainable lifestyle by offering an inspiring and accessible assortment of products and services that also takes into consideration customers with special needs.

ICA Gruppen's suppliers and other business partners must comply with the legislation in force throughout their operations in the countries where they operate. ICA Gruppen's requirements may go beyond what is set out in law. Suppliers and business partners must ensure that the products or services they provide to or via companies within ICA Gruppen fulfil these requirements. ICA Gruppen takes a positive view on local production.

ICA Gruppen have relationships with suppliers and not with countries. We follow the UN's and national government recommendations with respect to business relations with companies abroad.

## 2.3 Human rights

It is ICA Gruppen's firm conviction that all business must take place under fair and decent conditions. ICA does not accept discrimination, child labor, forced labor, violation of the right to freedom of association and collective bargaining, or any other failure to respect human rights. In all its operations and value chains ICA will use a risk-based approach to identify any risk of violation of human rights to then take appropriate action to minimize such risks.

ICA Gruppen's work is based on the UN Declaration of Human Rights, the UN Convention on the Rights of the Child, and the core conventions of the International Labor Organization (ILO). This is made clear in the company's agreements with all suppliers. ICA's suppliers of services and products are expected to meet the requirements set out in the above and must also themselves work to minimize the risk of violation of human rights in their value chains.

#### 2.4 Environment and Climate

ICA Gruppen work to achieve a continual decrease in the negative impact of our activities on the environment and climate. ICA Gruppen's environmental and climate work is an integral part of investment decisions and daily operations. It involves defining material environmental aspects such as energy use, transport, and refrigerants, and continually improving these in a resource-efficient way.

ICA Gruppen's work on climate aims to contribute to globally agreed climate targets, based on science. This includes consideration of the climate impact not just of our own operations, but also from our value chain through our relationships with suppliers and our customer offering.

#### 2.4.1 Transport and business travel

ICA Gruppen seek to achieve a continual decrease in the environmental impact of transport and business travel. ICA Gruppen's ambition is to increase resource efficiency and the use of renewable fuels.

#### 2.5 Health

ICA Gruppen will actively contribute to improved public health by leveraging the strength of our entire organization. This is always based on a scientific approach and official recommendations from relevant authorities.

# 3 Roles and responsibilities

Each member of the ICA Gruppen Management Team (IMT) is responsible for ensuring, within their area of responsibility, that work within ICA Gruppen is conducted in accordance with these guidelines. This responsibility includes ensuring that sufficient competencies and resources are available. Each manager is responsible for communicating these guidelines to their employees. Each employee has a responsibility to act in accordance with this governing document, thereby contributing to ICA Gruppen's ambition to be a leader in corporate responsibility. It is the IMT's responsibility to approve new versions of the general sustainability guidelines.

The Board of Directors' tasks include deciding policies for sustainability, establishing the structure for the company's sustainability reporting (annual and quarterly), and monitoring the company's work on sustainability.

Employees within ICA Gruppen's companies and stores shall be aware of the sustainability requirements that apply and shall ensure compliance with these within their respective product and business areas. The ambition is to constantly involve all ICA Gruppen's employees in the sustainability work, keeping them informed and providing ongoing training.

# 4 Exemption management

Exemptions from the general sustainability guidelines must be approved by ICA Gruppen's CEO.

# 5 Compliance

CR Group Management will monitor ICA Gruppen's compliance to the sustainability Guidelines and report this to ICA Gruppen's Management Team. Due diligence is used as one of our tools.

## 6 Annual review

The annual review of the sustainability guidelines is to be managed by the Chief Corporate Responsibility Officer and submitted to the ICA Gruppen Management Team for approval.
